- * Deliver signature-ready funding and accounting valuations to actuaries, including detailed demographic summary, gain/loss analysis and reconciliation to prior year's results
- * Provide technical support on select valuation and consulting projects for assigned clients
- * Assist consulting staff with the delivery of valuation and select consulting projects to clients
- * Work directly with consulting staff on assigned clients to scope project deliverables and own the timely and accurate delivery of those projects to the consultant
- * Advise Analyst Team Leader on ongoing and emerging project resource needs and timing; work with the ATL to secure optimal analyst resources to deliver valuation and consulting projects to the consultant
- * Partner with assigned project analysts to complete assigned projects, including the delegation of project responsibilities to project resources, the establishment of individual project plans for each valuation and consulting assignment and performance of assigned work
- * Ensure accurate and sufficient documentation of actuarial valuations and other special projects
- * Mentor and develop analyst staff through appropriate assignment of work responsibilities, providing frequent performance feedback and technical training
- * If CADP student, maintain progress through program requirements to obtain SoA and JBEA credentials
- * Execute on RPS' management team initiatives to develop RPS into a market leading organization
